Ordinary High Water Mark (OHWM) WHAT dOEs it MEan tO yOU? If you are a riparian the land above the OHWM is your private domain When the water levels drop below the OHWM, the riparian property owner has exclusive use of the exposed lake or river bed Everyone has the right to use the water to swim, boat or walk as long as they "keep their
